The Eventide Core Bond Fund seeks total return consistent with income generation by primarily investing in bonds with an expected weighted average duration between three and nine years. The Fund seeks to invest in securities issued by companies that demonstrate values and business practices that are ethical, sustainable, and provide an attractive investment opportunity.

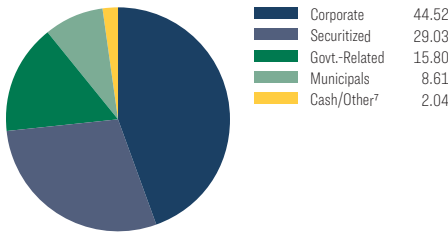

Portfolio Breakdown⁶ (%)

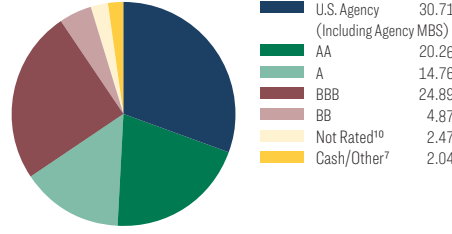

Beta is a measure of the volatility of a fund relative to the Index. A beta greater than 1 is more volatile than the Index. R-Squared is a measure of how a fund's performance correlates with the Index's performance and it can help assess how likely it is that beta is statistically significant. Standard Deviation of return measures the amount of variation in historical performance from period to period.
